Affiliate Seller – Terms and Conditions

An 'Affiliate Seller' is a person or organisation appointed by My Own Cop Ltd, to sell the My Own Cop Ltd Services by subscription, subject to the following terms and conditions:-

- There is no fee charged to be an 'Affiliate Seller' for My Own Cop Ltd
- The tenure as an 'Affiliate Seller' shall be at the sole discretion of My Own Cop Ltd and may be terminated, without notice, at any time
- The 'Affiliate Seller' agrees unconditionally to at all times, represent the best interests of My Own Cop Ltd, acting ethically and in good faith in the manner in which the 'Affiliate Seller' conducts all business activities related to My Own Cop Ltd
- My Own Cop Ltd reserves the right to approve, disapprove, amend or withdraw all such business activities as they see fit, and without explanation
- All Intellectual Property created by the 'Affiliate Seller' in accordance with this agreement, remains the sole property of My Own Cop Ltd
- The 'Affiliate Seller' may not in any way misrepresent themselves or My Own Cop Ltd as they conduct all business activities in accordance with this agreement
- The 'Affiliate Seller' shall provide:-
 - i. Proof of:-
 - a) Identity (Passport, Driving Licence, Birth Certificate)
 - b) Residence
 - c) An HMRC Tax Reference indicating Self Employment status
 - ii. A suitable email address (an @myowncop.com one can be provided – this remains the Intellectual Property of My Own Cop Ltd)
 - iii. A mobile phone number
 - iv. A nominated bank account for the purpose of paying commission
 - v. Access to their 'Affiliate Seller' accounts at any reasonable time, for the purposes of Audit
- The 'Affiliate Seller' will earn a commission for all Service Users, Sub Users and Lone Worker / Vulnerable Persons (Subscribers) who sign up to the My Own Cop service

- i. Only where the Subscribers pay a fee
- ii. At a maximum of 15% of the Net VAT figure
- iii. A minimum of 5% (of the 15%) must be offered as a 'Promotional Discount' to all new Subscribers
- iv. By BACS to the 'Affiliated Seller's' nominated account, 3 months in arrears
- v. Only whilst the Subscriber's account remains open and in credit
